OBJECTIVES AND INVESTMENT POLICY

Investment Objective

To generate income and some growth over the long term (5 years or shares) including listed closed ended Real estate investment trusts ("REITs").

Investment Policy

Portfolio Securities

 The fund invests in European (including UK) property related equities.
 The fund may also invest in other funds (including those managed by abrdn), cash and assets that can be turned into cash quickly.

Management Process

 The management team use their discretion (active management) to maintain a concentrated asset mix at sector and company level. Their primary focus is on selecting using research techniques to select individual holdings. The research process is focused on finding attractive high quality companies that can be held for the long term through the assessment of their business, the industry they operate in, their financial strength, and the capability of their management team. - Due to the active nature of the management process, the fund's performance profile may deviate significantly from that of the Index over

the long term.

Derivatives and Techniques

- Derivatives are linked to the value of other assets. In other words, they derive their price from one or more underlying asset. - Derivative usage in the fund is expected to be very limited. Where derivatives are used, this would mainly be in response to significant inflows into the fund so that in these instances, cash can be invested while maintaining the fund's existing allocations to equities


